# An Introduction from the FEDIAF President



It is a pleasure to introduce FEDIAF's annual report for 2024/2025. Our newly released Facts & Figures featured on pages 36-46 underscore our Industry's significant role. We are responsible for producing around 9.1 million tonnes of pet food worth around 29.3 billion, which feeds around 300 million pets. This is a big responsibility, which we take seriously.



Following the European elections and the establishment of the new European Commission, the political landscape in Europe has changed. At the same time, global realities have shifted, creating uncertainties and new opportunities for the pet food industry. In preparation for this, we have been reviewing FEDIAF's strategic approach and preparing the stepping stones for a renewed advocacy strategy, to ensure that the our industry's needs and concerns are clearly heard by stakeholders. We have also strengthened our internal communication tools, notably by introducing the FEDIAF Insights newsletter for members.

As we navigate this new reality, we remain steadfastly committed to support the pet food industry by continuing to deliver on FEDIAF's three pillars of action: ensuring the supply of safe and nutritious pet food, championing the pivotal role of pets in society and driving sustainability from farm to bowl.

# ENSURING THE SUPPLY OF SAFE AND NUTRITIOUS PET FOOD

The past year was marked by continuous advocacy efforts to ensure a supportive regulatory framework for the pet food industry. We have consistently emphasised the importance of maintaining access to key ingredients, including Category 3 animal fats.

Alongside this work at a European level, we have supported our National Association members with their local campaigns with a range of success levels in different markets. The provision of FEDIAF resources, factsheets, and guidance has undoubtedly empowered our members to proactively engage with local authorities, ensuring they stay ahead in their communications efforts.

Furthermore, the protection and authorisation of feed additives have continued to be a key focus for the pet food industry. As we continue to navigate these regulatory challenges, we remain vigilant in advocating for policies that prioritise safety and the long-term sustainability of our industry.



# PROMOTING THE ROLE OF PETS IN SOCIETY

Within the scope of our second pillar, FEDIAF

has two primary strands of activity. Firstly, we have continued to raise awareness of the significant benefits of pet interaction and importance of responsible ownership. Our work in this area has focused on communicating the latest science and working collaboratively with our fellow Pet Alliance Europe partners. We are committed to continue our close collaboration



with AnimalhealthEurope, FVE (Federation of Veterinarians of Europe) and FECAVA (Federation of European Companion Animal Veterinary Associations) in the future, to continue championing pet welfare and underscore the positive impact of pets on the lives of all Europeans, a concept we term #PetPower.

Moreover, we have emphasised the fundamental role of nutrition in pet welfare through our contributions to the 'feeding and watering' components of proposed companion animal welfare legislation. We have highlighted that FEDIAF's Nutritional Guidelines outline all the specific nutritional requirements of pets based on their life stage, health status, and activity levels.

FEDIAF takes great pride in its role in producing these comprehensive Guidelines, which are written and peer-reviewed by a Scientific Advisory Board (SAB) comprising independent board-certified veterinary nutritionists—veterinarians possessing expertise in nutrition.

DRIVING SUSTAINABILITY FROM FARM TO ROW!

In February 2025, we were delighted to publish the reviewed Product Environmental Footprint Category Rules (PEFCR) for Pet food, following a lengthy process with the European Commission and other Stakeholders. Since the beginning of our partnership with the European Commission in the development of Category Rules in 2018, we've remained dedicated to refining this methodology, which assesses the environmental impact of pet food products across their life cycle. This takes into account the pet food industry's unique characteristics, such as the use of animal by-products. Independent experts and the European Commission agree that assessing the environmental impact of these ingredients through economic allocation is the most relevant approach.

We have been actively involved in the discussions surrounding the green claims directive, highlighting the importance of Category Rules and the need for PEFCRs to be recognised as a the leading method of substantiation for green claims. We firmly believe that PEFCRs enable informed decision-making to improve environmental performance and facilitate consumer product comparisons, promoting sustainable purchasing habits.

During this period, we have also been involved in the finalisation of the Packaging and Packaging Waste Regulation (PPWR), broadly supporting the Reduce, Reuse, Recycle strategy, while underscoring that reuse targets need to align with regulations mandating new packaging for processed pet food, striking a balance between environmental goals and regulatory compliance. We continue engaging the European Commission and with Member States to ensure that implementing regulations at European and National level align with this approach.

#### A COLLECTIVE VOICE - THANK YOU

At FEDIAF, we are proud to be the collective voice of our members, comprising 15 national associations and 5 direct companies. With your support, we are able to advocate for the interests of the pet food industry throughout Europe. Through this collective effort, we strive to make a positive impact on the lives of the 300m+ pets in Europe.

I want to express gratitude to our Deputy Secretary General, Alice Tempel Costa, for her invaluable contributions throughout 2024 and 2025, leading the Secretariat through challenging times. With Aleksandra Prandota and the new members of the Secretariat team, Rachel Addy, Delara Khodadad and Franco Garbelotto, I firmly believe we are best prepared to continue FEDIAF's work and address future challenges. I would also like to acknowledge the significant contributions to FEDIAF's work by Fritha Flint and James Ramsay.

Our Annual Report offers a comprehensive overview of the initiatives organised within FEDIAF's Working Groups, committees, and task forces. Our members' expertise and involvement in these groups are immensely valuable, and we encourage anyone interested in joining to reach out to the team.







# The Pet Food Industry 2023/24 Key Working Group Milestones

FEDIAF is one voice working on behalf of the Pet Food Industry across Europe and has many achievements, which are possible due to the collaboration of its members. Here we highlight a few of these 'milestones' by Working Group:





# ADDITIVES AND UNDESIRABLE SUBSTANCES WORKING GROUP

FEDIAF successfully submitted an application for the authorisation of Xanthan gum in cats and supported submissions for Guar and Acacia gums. Significant progress was made on the Locust bean gum dossier, which required tolerance studies. FEDIAF continues to engage with applicants on several other feed additive dossiers.

In 2024, FEDIAF focused on addressing a major obstacle to the re-authorisation of certain hydrocolloids due to the lack of scientifically valid methods for detecting and quantifying them in finished products.



### **NUTRITION WORKING GROUP**

FEDIAF and FEDIAF's Scientific Advisory Board held two highly successful in-person meetings in 2024. These meetings provide industry and FEDIAF's independent nutrition experts a unique opportunity to meet and exchange on the most up-to-date science in the field of cat and dog nutrition. The FEDIAF Nutritional Guidelines were also updated and launched in September 2024.

In 2024, FEDIAF also had a great opportunity to work as a EFSA stakeholder providing our expertise on the update of their dietary model for cats and dogs (last published in 2011). EFSA's opinion on the dietary model was published here: https://www.efsa.europa.eu/en/efsajournal/pub/8858





#### **ANALYTICAL SCIENCE WORKING GROUP**

The Analytical Methods Working Group has been actively driving industry recommendations on the development of analytical methods and is in the final stages of developing a gold standard method for measuring inorganic phosphorus in pet food.



#### PRODUCT COMMUNICATION WORKING GROUP

The group is currently finalizing two new chapters of the FEDIAF Code of Good Labelling Practice for Pet Food. Additionally, members are preparing FEDIAF positions on current regulatory issues on a rolling basis.



## **ENVIRONMENTAL SUSTAINABILITY WORKING GROUP**

The group focused on the Packaging and Packaging Waste Regulation (PPWR) proposal, the Green Claims Directive (GC Directive) proposal, and oversaw the update of the Product Environmental Footprint Category Rules (PEFCR), endorsed by the European Commission in February 2025. The group also has oversight on FEDIAF's Task Force on Category 3 Animal Fat by-products.



# FEED MATERIAL AND TRADE WORKING GROUP

Throughout 2024, the group was actively involved in the EU Feed Chain Task Force's work to update the Feed Material Catalogue and clean the Feed Material Register. It also took part in discussions on making feed materials more circular through the Circular Feed Platform forum. FEDIAF strengthened its collaboration with DG TRADE and FoodDrinkEurope to monitor Free Trade Agreement negotiations with third countries and identify ways to improve cross-border trade.



### **SMALL PETS WORKING GROUP**

The Small Pets Working Group has recently finalized and published their Nutritional Guidelines for Feeding Pet Rabbits. These guides will be expanded in 2025 to include ornamental fish, guinea pigs and, later, pet birds.



#### **COMMUNICATIONS WORKING GROUP**

The Communications Working Group led the promotion of the FEDIAF manifesto, outlining the Industry's priorities and asks, with policymakers and stakeholders, while continuing to support other Working Groups in their strategic communication efforts. We also continued to lead internal discussions around a range of sensitive topics, such as Ultra processed foods, and laid the foundations for the development of a comprehensive public affairs and communications strategy. Finally, we continued our work with the Pet Alliance to promote #PetPower.

# A. Additives and Undesirable Substances Working Group

#### INTRODUCTION

### **Industry Expertise and Challenges**

The team consists of industry experts on legislation governing feed additives and undesirable substances, with additional expertise in key areas such as chemistry, toxicology, safety testing, and business strategy. The challenges faced by the group are dynamic and have a significant impact on our industry, requiring strong commitment and excellent teamwork from members and the Secretariat throughout the year.

### **Importance of Additives**

Additives play a crucial role in providing safe, stable and nutritionally balanced diets to pets across Europe. They also help ensure high levels of pet and owner acceptance in terms of flavour, texture and appearance – key factors that enable the European pet food business to thrive.

Only additives that have undergone the EU's strict authorisation, reauthorisation, or renewal processes are permitted for use. The Working Group continuously engages with the European Commission, the European Food Safety Authority (EFSA), and industry partners, including other trade associations, to ensure key ingredients are thoroughly assessed with the best available scientific evidence.

## **Managing Undesirable Substances**

Similarly, Undesirable Substances are a constant threat in a world where ingredients are increasingly sourced globally. FEDIAF, in association with the EU Commission are constantly vigilant to emerging legislative change. We work to understand the impact and respond on behalf of the EU pet food industry.

## **OBJECTIVES**

- Ensure the safety and effectiveness of ingredients used in pet food
- Maintain access to essential nutritional, sensory and technological feed additives to support excellence in safe and balanced nutrition.
- Facilitate innovation by ensuring feed additives remain available through authorisation or reauthorisation by European authorities.

#### **ACHIEVEMENTS**

#### **Feed Additives**

FEDIAF successfully collaborated across the industry and with external applicants to make significant progress towards authorisation of important feed additives:

- An application for the authorisation of Xanthan gum for use in cats was submitted in mid- 2024 and is currently under assessment.
- Tolerance studies in cats and dogs were conducted to support the applicant in the re-authorisation process of Guar gum, with submission in August 2024.
- Efficacy studies for Acacia gum as a texture stabiliser were performed to support the applicant.
- A feasibility assessment for developing analytical methods to detect and quantify certain hydrocolloids was prepared by Analytical Working Group and Additives Working Group experts.
- Preparatory actions were undertaken for the tolerance studies required for the Locust bean gum dossier, with the first tests launched at the end of 2024.

### **Undesirable Substances**

- The group engaged with DG SANTE in a targeted stakeholder consultation on the new draft Commission Recommendation on the presence of deoxynivalenol, zearalenone, ochratoxin A, T-2 and HT-2 toxins and fumonisins in feed
- A FEDIAF survey in mycotoxins was launched to self-monitor against current and future guidance on maximum levels in pet food.

Collaboration is key to the Working Group's success. A broad range of members contribute expertise from their respective companies and provide access to research facilities to create test diets, evaluate product acceptance, and obtain analytical results in support of FEDIAF's goals. This interdisciplinary, cross-functional, and international collaboration has been instrumental in delivering results of which we are proud.



# **B.** Nutrition Working Group

#### INTRODUCTION

One of FEDIAF's main objectives is to safeguard the well-being of pets by ensuring its member companies provide well-balanced and nutritionally sound pet food. To achieve this goal, FEDIAF's experts work together with a Scientific Advisory Board (SAB) that includes independent and renowned scientists from across Europe. The SAB advises on the scientific standards of the recommended nutrient levels, which are incorporated into FEDIAF's Nutritional Guidelines.

FEDIAF updates the recommendations for nutrient levels in pet food based on the latest peer-reviewed science, in close cooperation with the SAB. This enables the pet food industry to adjust the nutritional quality of complete diets for dogs and cats according to state-of-the-art scientific knowledge.

#### **OBJECTIVES**

- Contribute to the well-being of pets by ensuring the manufacture of nutritious and palatable food reflecting the most recent developments in scientific knowledge.
- Ensure FEDIAF Guidelines are the 'go-to' document on pet nutrition in Europe and beyond.
- Ensure a level playing field and enhance scientific cooperation between pet food manufacturers, pet care professionals, and competent authorities.

### **ACHIEVEMENTS**

#### **Updated FEDIAF Nutritional Guidelines**

The FEDIAF Nutritional Guidelines for Complete and Complementary Pet Foods for Cats and Dogs were updated. FEDIAF officially launched the updated guidelines at the Annual European Society of Veterinary and Comparative Nutrition (ESVCN) meeting held in Belfast, Northern Ireland, in September 2024.

# Recognition of FEDIAF Nutritional Guidelines by the Global Alliance Pet Food Associations (GAPFA)

"GAPFA supports the recognition of and use of the AAFCO and FEDIAF nutrition guidelines. Whether following AAFCO, FEDIAF, or an alternative set of internationally recognized, science-based nutrition guidelines, the guidelines should be considered in their entirety and used as a whole because each guideline was based on a specific set of scientific assumptions."

# FEDIAF Participated as a Sponsor at the ESVCN Congress in Belfast, Northern Ireland

The 28th Congress of the European Society of Veterinary and Comparative Nutrition (ESVCN) was held from September 11th to 15th, 2024, in Belfast, Northern Ireland. FEDIAF continued its annual sponsorship of this congress and was present with a booth providing hard copies of the updated 2024 Nutritional Guidelines, as well as a selection of FEDIAF factsheets for attendees. The provision of materials was well appreciated by participants. The annual ESVCN congress provides another opportunity for members of the FEDIAF NWG to meet and engage with members of the SAB, among other stakeholders.

## **Safety of Phosphorus in Cats**

The FEDIAF Nutrition Working Group (NWG) is actively engaged in the scientific discussion around the high intake of inorganic phosphorus compounds (such as NaH<sub>2</sub>PO<sub>4</sub>) and their effects on indicators of kidney function in cats. This collaboration includes widely recognized veterinary and pet nutrition experts from our SAB. The NWG and SAB reviewed the latest research on this topic published by Reynolds and colleagues<sup>1</sup>. This new study provides additional support for the level of inorganic phosphorus mentioned in the footnote of the Nutritional Guidelines. The paper was included in the updated FEDIAF Nutritional Guidelines published in 2024.

# Initiation of Collaborative Work Between SAB and NWG on Creating New Pet Food Fact Sheets

SAB members, together with NWG members, have formed subgroups to work on new pet food fact sheets focused on grain-free diets, insect-based ingredients in pet food and awareness about weight management in pets.

# C. Analytical Working Group

#### INTRODUCTION

FEDIAF's mission is to facilitate the supply of safe and nutritious products. The importance of analytical methods continues to evolve due to challenges arising from changes in the regulatory landscape, external reports on contaminants or nutritional parameters, and the need for a clear assessment of method robustness and applicability in the additives re-authorization process.

The Working Group on Analytical Methods has become a reference point for all topics and questions related to analytical methods.

#### **OBJECTIVES**

- Provide internal advice to other Working Groups.
- Promote analytical method development, verification, or standardization for the pet food industry.
- Promote transparency and reliability by developing standardized methods for analysing specific compounds in pet food.

#### **ACHIEVEMENTS**

# **Driving Industry Recommendations on the Development and Use of Analytical Methods**

Actively driving industry recommendations on the development and usage of analytical methods, the Analytical Science Working Group is finalizing its studies to develop a standard measure for inorganic phosphorus. The group is now also working on a roadmap for verifying the robustness of current methods to measure acrylamide in pet food, with the aim of providing a recommendation.

# Providing Expertise on Analytical Methods to the Industry

One of the Group's missions is to provide internal advice to other Working Groups. A second workstream has been developed in collaboration with the Additives Working Group, focusing on analytical methods for hydrocolloids—a vital topic for both the industry and FEDIAF specifically.





# D. Product Communication Working Group

#### INTRODUCTION

The Product Communication Working Group comprises experts in the field of labelling and product communication. The team has excellent technical and legal expertise.

Pet food labelling has evolved significantly in recent years. What was once a simple pack with minimal information (mainly limited to mandatory declarations) has transformed into a comprehensive product communication approach. This now includes not only more content-rich packaging but also TV advertisements, complementary online information, colourful leaflets, and more.

Although pet food falls under feed regulation, it has its own specificities, which FEDIAF ensures are taken into account by EU authorities.

**OBJECTIVES** 

- Updating and harmonizing the FEDIAF Labelling Code by developing new chapters, clarifying labelling rules, and contributing to advocacy proposals to align with regulatory changes.
- Engaging in regulatory advocacy with EU bodies to promote simplified labelling practices within the industry.
- Addressing emerging topics, assessing their relevance for FEDIAF, and determining appropriate actions based on industry needs and regulatory developments.

# **ACHIEVEMENTS**

## **Code of Good Labelling Practice**

The Code of Good Labelling Practice for Pet Food, endorsed by the European Commission in 2011 and 2018, is a living document that must be maintained in line with the everevolving legislative landscape.

The Working Group is currently finalizing two new chapters on organic pet food labelling and Feed for Particular Nutritional Purposes (PARNUTS), based on the respective EU regulations.

This updated Code, which also includes a legislative update and clarifications, will help manufacturers properly communicate their products to consumers, ensuring standardized labelling that facilitates buying decisions.

# Providing Industry Guidance on Good Labelling Practices

In line with its commitment to advocating for good labelling practices, the Working Group has provided its expertise on emerging issues related to product communication. As part of this effort, the group has started collaborating with the Nutritional Working Group on voluntary carbohydrate labelling. Additionally, the Product Communication Working Group continuously responds to labelling-related questions from the industry.



# E. Environmental Sustainability Working Group

#### INTRODUCTION

FEDIAF's Environmental Sustainability Working Group (ESWG) has been an integral part of FEDIAF since 2019, working with decision-makers around Europe as a trusted voice on sustainability topics in the pet food sector.

In 2024, FEDIAF built upon its role as a responsible stakeholder in the EU's Green Deal debate and worked towards better regulation in packaging and packaging waste, and on the substantiation of environmental claims while continuing to work on the PEFCR for pet food.

#### **OBJECTIVES**

- Promote the responsible use of resources from farm to bowl and minimise the sector's environmental impact whenever possible.
- Collaborate with authorities, regulators, academics, and other related stakeholders and contribute efficiently to policy shaping.
- Ensure that a favourable framework for more sustainable pet food production is adopted.

### **ACHIEVEMENTS**

## **Packaging legislative framework**

Throughout the year, FEDIAF has continued to monitor the Packaging and Packaging Waste Regulation proposal and advocate our industry's position with MEPs and other decision-makers. We also coordinated our advocacy efforts with other stakeholders, engaging with our umbrella organization, FoodDrinkEurope, and the EU packaging chain forum.

Our advocacy played a part in removing amendments from the plenary vote that would have significantly impacted our sector regarding reuse targets due to their inconsistency with Animal by-products Regulation 142/2011, which requires that 'processed pet food must be packaged in new packaging.'

The co-legislators agreed on a joint text in 2024, leading to the publication of the PPWR in the EU Official Journal in January 2025.

As in previous years, FEDIAF remained vigilant regarding national packaging provisions that fail to comply with the EU Single Market's principles and continued advocating for harmonization in sectoral legislation

FEDIAF members are committed to achieving the objectives defined by PPWR. The European Commission's proposal presents a great opportunity to encourage harmonization across the EU, and we thank decision-making bodies for considering the interests of the 139 million pet-keeping households in the EU.

FEDIAF will continue to engage in the implementation phase of the PPWR, as significant secondary legislation is expected in the coming years, and to monitor national packaging measures closely.

#### **Green Claims Directive**

FEDIAF continued advocacy efforts on the Green Claims Directive in view of the trilogue negotiations between the co-legislators.

In 2023, the ESWG drafted a position paper calling for a harmonized approach to legislation and the adoption, where possible, of an accepted methodology for benchmarking and substantiating environmental claims.

FEDIAF continued its outreach and advocacy efforts toward legislators, conveying strong support for PEFCR (Product Environmental Footprint Category Rules) as the benchmark method for substantiating environmental impact claims in any sector where a PEFCR has been developed. FEDIAF contacted MEPs on the ENVI and IMCO committees in the European Parliament to recommend improvements to the proposed text and circulated our Position Paper on the Green Claims Directive, calling for robust substantiation, harmonization of rules, and limiting the proliferation of national schemes.



# Product Environmental Footprint Category Rules (PEFCR) for the pet food industry

The endorsement of the PEFCR in 2018 marked a key milestone for FEDIAF and its members. The PEFCR provides a credible, robust, and accessible methodology developed to help members assess the environmental impact of their pet food products using a harmonized approach. This allows consumers to make informed purchasing decisions by offering clear, reliable, and comparable information across products.

Continuing this work, FEDIAF established a Technical Secretariat to coordinate input from the Review Panel before submitting the final draft to the European Commission at the end of 2024. The PEFCR for Pet Food was officially approved by the European Commission in February 2025.



## **Protecting Category 3 Animal Fat by-products**

As part of the European Green Deal, the EU adopted even more ambitious climate goals, setting a target of a 55% reduction in greenhouse gas (GHG) emissions by 2030 and a long-term goal of net zero GHG emissions by 2050.

FEDIAF welcomes the ambitious climate package and supports the mainstreaming of renewable energy across all economic sectors. However, upon examining the potential and effective impacts of various Green Deal legislations, FEDIAF identified a serious risk for the sustainability of our industry regarding the carbonisation of transport: the use of Category 3 animal by-products (CAT 3) as biofuels. CAT 3 animal by-products are key ingredients in pet food production. FEDIAF firmly believes that food not intended for human consumption should be used in pet food first, in line with the EU's own waste hierarchy. Other types of animal by products, such as Category 1 and 2 animal fats, which do not meet the necessary standards for use in pet food due to safety reasons, are much more suitable for biofuels.

Unfortunately, failing to safeguard Category 3 animal fats from use in EU biofuels could trigger a higher carbon footprint for the pet food sector, as feedstocks with a higher environmental impact might be used to fill the gap.

In 2024 we met with key stakeholders and developed several articles, press releases, and joint statements to educate policymakers and our social media followers about the impact these legislative files might have on the pet food sector.

Efforts are being made to assist national associations in advocating for the protection of Category 3 animal fats from use in biofuels in national legislation, especially in light of the implementation of the revised Renewable Energy Directive. FEDIAF continues to engage European policymakers in anticipation of further revisions to the European legislative framework on renewable energy.

# F. Feed Material and Trade Working Group

#### INTRODUCTION

The Feed Material and Trade Working Group is made up of industry experts focusing on plant- and animal-derived raw materials, supported by expertise in trade and potential restrictions.

The rules for animal derivatives fall under the Animal By-Products Regulations, which contain over 350 pages of stringent provisions to safeguard human and animal health. These rules also establish the legal framework for sourcing safe raw materials for our industry. Every proposed amendment must be thoroughly scrutinised to ensure it remains suitable for the pet food sector.

As a group, we draw on our members' experience and insights to identify potential issues. Sometimes, a simple 'and' or 'or' in legal text can make all the difference.

#### **OBJECTIVES**

# Maximising Opportunities for FEDIAF Members in Marketing Their Products

- Ensure valuable feed materials remain available for use in the pet food industry.
- Establish appropriate sourcing and processing standards to protect animal and public health.
- Facilitate intra-community trade and exports to third countries.

# **ACHIEVEMENTS**

## **Feed Materials Catalogue**

The group worked closely with the EU Feed Chain Task Force to submit the 5th amendment to the EU Catalogue of Feed Materials. The final proposal was shared with the European Commission in November. The Standing Committee on Plants, Animals, Food and Feed (SCoPAFF) is expected to review it by Q2 2025, with implementation by year-end.

## Brexit - Practical Implications & Keeping Stakeholders Engaged

The Working Group remained a key platform for sharing technical insights between members and UK Pet Food, ensuring that those trading with the UK stay informed on developments related to import conditions under the Border Target Operating Model issued by the UK government.

FEDIAF contributed to the consultation on proposals for product-level 'Not for EU' labelling requirements across Great Britain and monitored further developments.

Together with UK Pet Food, we worked to secure a fit-forpurpose timeframe for implementing rules that support trade between Great Britain and Northern Ireland.

## **Cooperating with Legislators**

The Working Group played a key role in facilitating communication between the industry and the European Commission on export facilitation to third countries and in addressing new constraints on imports into the EU (e.g. animal proteins from China).

This includes regular participation in the EU Market Access Working Group to ensure pet food remains a priority for regulators when opening new markets.

The group also initiated discussions with DG Trade on several WTO notifications, including those from Saudi Arabia, South Korea, and Canada.



# G. Small Pets Working Group

#### INTRODUCTION

FEDIAF members manufacture food for all pets, including small mammals, ornamental birds, ornamental fish and others. For these, specific topics or discussions can arise that are not covered in detail by other existing Working Groups.

In order to give exposure to those that are smaller, FEDIAF has established a dedicated Small Pets Working Group. This Working Group addresses the interests of all companion animals apart from cats and dogs. It represents a wide range of manufacturers across the membership who cater for a large number of different species.

### **OBJECTIVES**

- · Advocate for the interests of pets other than cats and dogs in legislative pet food matters.
- Develop nutritional guidelines for a wide range of new species including ornamental fish, pet birds, guinea pigs, and others.
- Produce educational resources for pet care professionals and pet owners.

· Provide expertise on nutrition for small pets, including

In 2024 the Small Pets Working Group finalized and published the Nutritional Guidelines for Feeding Pet Rabbits. Starting in 2025, these guides will be expanded to include ornamental fish, guinea pigs and, later, pet birds.





# H. Communications Working Group

#### INTRODUCTION

The Communications Working Group continues to increase the visibility of FEDIAF as the responsible voice of the European pet food industry by promoting the three pillars: nutritional expertise, our sustainable credentials and the benefits of pets in society. It also collaborates to support specific Working Group activities.

We have continued to manage communications across a wide range of platforms and formats: website, events, newsletters, press releases, statements, factsheets, and our presence on LinkedIn and X.

#### **OBJECTIVES**

- To promote FEDIAF's scientific and technical expertise.
- To share the benefits of pet interaction and ownership in addition to supporting pet welfare.
- To communicate FEDIAF's commitment to the environment and the Industry's sustainability credentials.

# Public presentation of the FEDIAF Manifesto and expanded stakeholder outreach

The Communications Working Group coordinated a public event to present the FEDIAF Manifesto to the public and continued to work to enhance the presence of FEDIAF in Brussels circles before and post elections. To this end, we have assisted the secretariat in developing the first stepping stones of an advocacy and communication strategy, that will enable a holistic and coordinated approach to public affairs in the future.

## Increasing Collaboration with the Pet Alliance

Cementing the relationship with our fellow founding partner AnimalhealthEurope, and our two more recent partners FVE (Federation of Veterinarians of Europe) and FECAVA (Federation of European Companion Animal Veterinary Associations), in September 2024, we held our annual event at Townhall Europe. We welcomed over 100 guests including Members of the European Parliament, Commission and Council, animal welfare organisations, assistance animal associations and pet industry stakeholders plus many four-legged friends, to celebrate #PetPower.

We also had the privilege of hosting Marie-José Enders-Slegers, President of IAHAIO (International Association for Human-Animal Interaction Organisations), as a special guest speaker. Marie-José highlighted the essential roles that pets play in everyday life and in crisis situations around the world, with a special focus on therapy animals.

# Continued Engagement with Stakeholders and Media on Cat 3 Campaign

FEDIAF members (as part of Cat 3TF) worked collaboratively to highlight the unintended consequences of allowing the use of Cat 3, critical pet food ingredients, for biofuels. Our communications tools including factsheet and video have helped National Associations in their national efforts.

## Supporting PPWR, Green Claims and PEFCR

We supported ESWG in the polishing of documents that promote the sustainable credentials of the Pet Food Industry.

## Social Media, Press articles and Press Releases

Over the year, FEDIAF's followers on LinkedIn have increased by over 3000 to over 11,500 followers. Our nutritional expertise and resources are always extremely popular and well shared.

FEDIAF has contributed features and comments for articles in Pets International, International PetFood, Feed Navigator and All About Feed and Pet Food Processing. The association also circulated press releases on several topics, such as publishing new Facts & Figures report, Annual Congress, the Re-election of the board of Governors, the Publication of updated Nutritional Guidelines for Cats and Dogs, as well as for Rabbits.

### **Supporting the Animal Welfare Task Force**

From its establishment at the end of 2022, the AWTF has met regularly to monitor legislative developments with the aim of influencing content affecting our industry and its objectives.



Leveraging the expertise within FEDIAF in nutrition, the Animal Welfare Task Force responded to the Commission's consultation on the proposal for a Regulation on the welfare of cats and dogs and their traceability, and prepared a position paper with suggested amendments that was circulated with the relevant stakeholders in the European Parliament. FEDIAF also reached out to the Veterinary attachés of Permanent Representations of EU Member States in Brussels to raise awareness on our position paper and highlight FEDIAF's input on Cat and Dog nutrition.

The taskforce has also continued to strengthen its relationships with pet ecosystem stakeholders, including Four Paws, Eurogroup for Animals and Animal Health Europe, to understand the different perspectives and work with regards to the EU animal welfare revision law and more.





# **Governance and Structure**

FEDIAF is the trade body representing the European pet food industry. We work with our members and collaborate with authorities, regulators, and academics to ensure favourable conditions for the supply of safe, nutritious, and palatable products.

We work through a committee structure and the Secretariat works closely with the Communications Working Group and Executive Committee – reporting to the General Assembly.



#### European Pet Food Data: An Updated and Robust Approach

FEDIAF's Facts & Figures are highly regarded throughout Europe and frequently referenced by authorities, stakeholders, and the media. We are delighted that the European Commission cites our pet population data during discussions, alongside numerous pet industry and veterinary colleagues.

With this recognition comes the responsibility to ensure our approach remains robust and thorough. Last year, we undertook a comprehensive update, working with external data experts at Soulor Consulting to meticulously review both pet population and market data. This year, Soulor has continued to manage the data collection process.

As per tradition, we have liaised with all 15 of our National Association members, who have supplied local population figures and market data—where available. The participating countries are listed in the Appendix (page 47). Soulor Consulting has conducted a rigorous review, aligning data and applying additional layers of verification against previous records, inflation figures, and other relevant metrics.

It is important to note that our list of European countries has evolved. Russia is no longer included and we have incorporated a set of new countries that were previously not included to ensure that the data covers all of the European Union (EU), European Economic Area (EEA) and most of the remaining Council of Europe member states (the report now covers 41 of the 48 CoE members).

Mirroring last year's methodology, we now gather data from two years prior to publication. Therefore, in 2025, we will publish data from 2023\*. Due to changes in the countries included, we advise against making direct year-on-year comparisons.

For further insights into our methodology, detailed notes are available in the Appendix, ensuring transparency and clarity in our data collection and analysis processes.

<sup>\*</sup>No Swiss data was collected in 2023 or 2024. In 2025, a new methodology was used, and this data is included in the report and Total Europe figures. A notable change from 2022 makes its inclusion necessary.












# Facts & Figures: European Population Total Excluding Aquaria

#### **Appendix**

#### FEDIAF ANNUAL POPULATION DATA METHODOLOGY 2022 ONWARDS

This year national associations provided data for 2023 (some markets cannot provide the most recent year of data in time for FEDIAF's report therefore it was decided in 2023 that the report to be published in 2024 would harmonise data for 2022) and Soulor Consulting made estimates for the other European countries based on data published by FEDIAF for 2022 using a new methodology.

Most of our national associations provide FEDIAF with aquaria as they now understand that we collect aquaria not fish. As a result, FEDIAF has not had to 'translate' fish numbers into aquaria. Where markets have not provided any data, Solour has based figures on what was published in 2022 and the number has been aligned according to the average number of pets per household.

This year 11 additional countries have been added and one removed (added = AL, BA, CY, IS, LI, MT, ME, MK, MO, RS, XK; removed = RU). For countries where national associations provided data, this data was checked against 2022 to ensure consistency and in some cases 2022 data was published last year this data has been used again for 2023 (where NA have submitted). For countries that did not submit data, Soulor Consulting used 2022 populations and calculated these missing data using a new methodology. All final population data was rounded (growth rates are calculated using the unrounded data).

The Total Europe & EU total households owning a pet percentages are calculated from those National Associations that submitted a number for households owning a pet (total) which were FR (estimated from 2022), DE, IT, NL, ES (estimated from 2022) & GB. Those countries account for 59% of the total pet population (Total Europe, 64% for EU where GB was removed from the calculation as no long in the EU). Those calculated percentages of households owning for those five/six countries was applied to the number of total households for Total Europe and EU. This year sub totals have been added for EEA and other Council of Europe (CoE) countries.

#### FEDIAF ANNUAL MARKET DATA METHODOLOGY 2022 ONWARDS

As with Population data, this year national associations were asked to provide data for 2023. Where a national association was not able to provide volume or value sales for the market, this missing data was calculated based on expected price per kilo. Where a country did not submit, the total for total pet was estimated using a new methodology. Last year national associations were asked to provide more detail than in previous years to cover, cat and dog food, split into wet, dry and treats. As there has been a change in methodology again this year as 2022 data has been reviewed with the new list of countries and missing/ new countries that do not have NA submissions have been calculated by assigning each new/missing country a proxy country and modelling the total market size on that country's pet population and price per kilo and VAT rate. For countries that are estimated the 2022-2023 growth is also based on rate of consumer inflation for 2022-2023.
