In his new role at FEDIAF, Luca will lead the Association's **technical and scientific work**, supporting members across a wide range of topics and ensuring that the sector's positions are underpinned by robust evidence and aligned with the highest standards of safety and quality. He will also play a key role in **representing the pet food industry in technical discussions with the European Commission, EFSA and other stakeholders**, contributing to constructive and science-based policymaking.

His appointment further strengthens FEDIAF's technical capacity at an important moment, as the Association continues to engage on major regulatory files shaping the future of pet food, animal nutrition and sustainability across Europe.
